#### 1 STATUS

Ali Hasan Mangi Memorial Trust was established in Febuary 2008 as a Non-Profit Organization. The main objective of the Trust is to provide funds for educational insitutions for general and vocatinal traning and to develope Projects for the benifit of destitute citizens living in rural arreas as envisaged under clause (5) of TrusDeed . The income of the Trust is exempt under Rule 212 of the Income tax Rule 2002

## 2 SIGNIFICANT ACCOUNTING POLICIES

## 2.1 Basis of preparation of financial statement

These financial statements have been prepared under the historical cost convention.

Property and Equipment are stated at cost less accumulated depriciation. Depriciation is charged to income applying the reducing balance method at the rates specified in Note3. Depriciation on addition is chaged for full year in which the asset is purchased whereas no depriciation is charged in the year it is sold or disposed off.
